

Chairman's Notes

Since the AGM I am honoured to have been elected as Chairman of your Council.

Elizabeth Ball was Chairman for five consecutive years and we all owe her a debt of gratitude. On your behalf I record in this Newsletter a warm thank you as a tribute to her able and diligent work in achieving so many successful occasions for the breed, as well as leading us during some difficult times.

Barry Allen continues as Vice-Chairman and, with Cath in great support, he contributes much hard work - often unknown but nevertheless important to the Society.

Both Elizabeth and Barry have advised and helped me a lot.

I will not duplicate items that are covered in other sections of the Newsletter. I do welcome comments and criticisms, which of course I expect, but trust they will be positive and unselfish. This will give us the payment we deserve, which can only be measured in terms of the pleasure we have in breeding, owning, enjoying and preserving our heritage.

100 years of my family with ponies is hard to condense. Many of you won't know me. I had been out of the limelight for a while until my father, Roy, who was your President, died nearly ten years ago. His grandfather, Robert, owned and bred ponies from the time he moved to The Linnels in 1890. They were mostly driving ponies - Hackneys and other trap/flat cart ponies.

My grandfather, Roy, was buying his first ponies at that time when only in his teens. Before the First World War he decided to concentrate chiefly on Fells, but always kept a few Dales and a good hunter. As their secretary he lead the field in both re-establishing the Dales Pony Society and in publicising the qualities of the Fell worldwide after their numbers were depleted in the 1914-18 War. I have his notebooks in my drawer!

He wrote a book, "A Lifetime with Ponies" soon before he died in 1949. I plan to re-publish it. It contains a wonderful historic story, with many good tales, which picture his fanaticism about Native ponies and Fells in particular.

My father, another Roy, continued this tradition with enthusiasm all his life. He had an in-built natural instinct with horseflesh, as well as with "horsey people", and this covered aspects from playing polo in Persia, flat racing in the desert, crossing rough hill country when hunting the Haydon foxhounds for 15 seasons, driving a pony and trap to Hexham station to catch the train, yoking the hunters & Clydesdales to do farm work, 60 years leading a Pony Club - all this as well as his stud of Fells! They also ran a family engineering business in Newcastle, as well as the home farm.

I have no wish to sell myself except by example but I've picked up lots of bits from my forebears.

I showed my first Fell under saddle at the NPS show on Roehampton Polo Field in 1949, aged 11. We were just middle of the line up; father was Champion on a 4 year old, I think, which he later sold to Australia. I've been learning ever since!

Supported by Sarah, and my children, we can face the challenge and succeed in "changing times". Our future has to be good. Thank you all and good luck.

Good luck also to Templeton finalist Bewcastle Boy Blue, the gelding owned by Mary Longsdon and Richard Goddard, featured on the front cover, when he competes at the end of September. He is the first Fell to make it to the final of this prestigious award.

Equally, those ponies which have qualified for Olympia deserve our good luck and support. If you have the opportunity to go to the Horse of the Year Show to cheer them on, I'm sure they would really appreciate it.

The finalists this year are Waverhead Black Magic owned by Mrs Sheila Hardy and ridden by her daughter Alison, who swept the board at Ponies (UK) by winning Best Fell, Ridden M & M Champion, Ridden Supreme Champion of the Show, Reserve Supreme of the Show and was narrowly beaten into second place in the Pairs with Heltondale Rob owned by Mr D Eltringham.

Darrenvale Jason, owned by Mr and Mrs Russell Sutcliffe won the Fell In Hand Championship & went on to become Supreme In Hand M & M Champion at Ponies (UK).

And last but not least, Miss Debbie Boylan with her gelding Lownthwaite Hot Shot completes the trio. It promises to be an exiting finale to an excellent year for the breed in the showring.



Give the Fell a Chance (Spring '98)

I heartily concur with the sentiments of Kath McVicker.

Please do not be put off showing your ponies in mixed M&M classes. I have ownership of a Fell gelding who is my pride and joy. I bought him from the late Mr Clifford Howarth, as a 5 month old foal. Knowing very little about the Fell pony I was delighted to have him complimented by local farmers as "a bonnie lad" and so determined to try my luck in the show ring.

Not owning transport of my own we don't get to many shows & we don't get very far afield. Despite another Fell pony breeder who told me, based on my description of him to her, to forget he was registered as a Fell pony and just put him in Handy pony & WHP classes I decided to try my luck anyway. I entered him in a mixed class for 2 year olds at a show for coloured ponies and to my delight he was placed 2nd. As this was his first time out anywhere on his own, and the first time he been near a show, his behaviour was not exemplary so I was over the moon with his success.

We did not show again until the following year. This time we entered the 3 y.o. mixed M&M class at a local show. Under a Fell Pony Society judge, and despite having a white foot, the pony won and took the Championship. At two later showings last year he took 3rd under a judge who didn't recognise his breeding without asking, and 4th. The last result was partly my fault but it is not easy keeping up with a trotting Fell when hampered by a broken toe!

So the moral of my letter is "Never say die" and keep presenting your Fells to as many judges as possible so the breed is far more readily recognised and, who knows, you may enjoy as much success as I've had with my Bolton Abbey Hero. Happy rosette hunting to you all.

Emphasise the Positive

Since the media publicity of the "foal syndrome" which has ranged between the sensible and informative to downright ridiculous and alarmist, I feel that some of the marvellous achievements of our members have been totally eclipsed.

Darrenvale Jason's Reserve Championship at Olympia 1997 was mentioned in one line in the Spring 1998 Newsletter whilst pictures of and information about sick foals dominated the front cover and inside pages. Earlier in the same year Fell ponies had been outstanding at the Royal Show with Darrenvale Jason winning the Fell Championship and then going on to take the Supreme in hand title. Deborah Chadwick's Hedgethorpe Bluebell went on to win the Supreme Breeder's Championship after winning the Fell Youngstock section.

1998 has also been an incredible year for Fells. Mrs Hardy's Waverhead Black Magic was indeed magic at Ponies (UK) when, after winning the ridden Fells, he went on to win the Supreme M&M ridden Championship and Reserve Supreme of the show, and together with Mr Eltringham's Heltondale Rob narrowly missed winning a huge M&M pairs class. Mr Sutcliffe's Darrenvale Jason was the Fell in hand Champion and went on to wow the crowds with an in hand display that outdid even the Welsh Cobs, to take the Supreme M&M in hand title. At the same show Lizzie Briant and Townend Callum beat strong opposition to take the coveted Kingsford Championship title.

At Malvern, the Williamson family's Townend Lucy IV took Reserve in the Super Solvitax Veteran ridden final whilst Deborah Chadwick again qualified for the "workers" at Wembley with Stennerskeugh Dandy.

Miss Longsdon created a first when Bewcastle Boy Blue qualified for the Templeton final and recently Mr P Metcalfe's Lunesdale Prince Henry was beaton by one one point in an open dressage class of 33.

There are doubtless many others who have achieved great things and even more who simply enjoy their ponies quietly at home, but if this is to continue and the Breed is to have a future we must now put the "foal syndrome" into perspective and publicise instead the versatility, successes and pleasure of owning a Fell pony.

Minutes of the Annual General Meeting held on 28th March 1998 at Lowther Parish Hall, Hackthorpe, Penrith at 1.00 pm

The Chairman, Mrs Ball, opened the meeting at 1.30 pm, the start having been delayed by a technical problem.

1. Apologies for absence

Apologies were received from Mrs S Audley, Mrs A de Belin, Mr N Tweedie Smith, Mr G Jackson, Mrs J Fairburn, Mr G Guy, Mrs I Potter, Mrs P Robson, Mr F Dargue, Mr J Hodgson and Mrs G Cockbain.

2. Minutes of Previous Meeting

The minutes of the last meeting held on 18th October 1997 were read. They were accepted as a true and accurate record, proposed by Miss M Longsdon, seconded by Mr R Bicknell.

3. Matters Arising

Mr S Kelly suggested in the interests of time that minutes be circulated in advance of the next general meeting. It was agreed minutes will in future be published in the Newsletter.

It was noted that the Dartmoor pony has been accorded Rare Breed status.

4. Chairman's Report

Mrs Ball thanked everyone for attending. She paid tribute to the work of Dr Knottenbelt, the Fell Pony 2000 team and the volunteer helpers who had organised a successful series of regional breeders' meetings about the Syndrome and the work being done towards finding a solution to the disease.

5. Election of Council and President

A secret ballot for appointment of 5 council members was held, the results being announced at the conclusion of the meeting. Nominations for President were Mrs M Laing, proposed by Mr A Morland, seconded by Mr R Sutcliffe, and Mr D Scott, proposed by Mr R Bicknell. Mr Scott declined. Mrs Laing was duly re-appointed.

6. 1996/97 Accounts and re-appointment of Auditors

There were no queries about the accounts which had been circulated previously to members. Adoption was proposed by Mr P Forsman, seconded by Mr S Adams. The auditors, Stephenson Armstrong & Co, were re-appointed, proposed by Mrs S Charlton, seconded by Mr M Allen.

7. Presentation of Awards

Secretary's Report 8.

The report commenced with thanks to the many hard working volunteers who help the Secretary throughout the year. Details of the SideSaddle for Survival Ride organised by the Rare Breeds Survival Trust in this their Jubilee Year were given and sponsorship forms offered to interested members. Members were invited to collect new registration forms for 1998 foals. It was explained the computer program modifications needed to produce passports were not complete, nor the pages of the passport designed A binding system had been purchased and vinyl covers printed. Breeders were advised to send in applications as usual, observing the deadlines, although delays in issuing passports were likely until everything was ready and working.

Membership total was 1145 members and bank balances were given as at 27 February - Current Account £7,295.53 and Deposit Account £6,540.20.

Reports of Delegates and Sub-Committees 9.

Mrs A Newall/Trainee Judges: Mrs H Moss, Mrs B Hodgson and Mrs S Helps had moved onto the "B" Panel, joining Miss S Muller, releasing 4 vacancies for trainees from the waiting list, who have already been invited. Miss M Longsdon/NPS: The revisions to the NPS's constitution had been

passed at its AGM. Mrs P Renwick (Shetland) and Mr D Mansell (Exmoor) were appointed as the native breed society representatives to Council under the new rules in the post AGM Mountain & Moorland meeting.

Southern Show: The 10th to take place will happen on 13th September by kind permission of Sir John Miller at Shotover, Oxford with 3 rings to accommodate increasing entries. Mrs Ball, Mrs Lightfoot and Mrs Johnson are to judge. Anniversary special rosettes & other goodies will be given to ponies.

Mr R Sutcliffe/BHS: The recent Horse & Pony Breeds Committee meeting had included 2 speakers. Mr Waterhouse, Trustee of the BHS, discussed the newly reorganised BHS. Mr Jones from BEVA spoke largely about the need ' for passports for all equines if commonly used drugs, used to treat colic and lameness for example, are still to be available for veterinary administration. The EU requires maximum residue levels (MRLs) of drugs to be established in any animals entering the human food chain, which includes equines. Without establishing MRLs, drugs will be withdrawn and any vets using them would be breaking the law. The research to establish MRLs is expensive and slow, which is why some products will disappear. Sutcliffe quoted the following figures: 300,000 equines are slaughtered annually in Europe, of a population of some 2 million, producing 168,000 tonnes of horseflesh, equivalent to 1 lb per person for everyone in the EEC. 15,000 equines originate from Britain. This is a key issue in the aftermath of the BSE scare. Additionally, vets are now demanding "medical" passports. in which all veterinary treatment could be recorded, ensuring unfit animals do not go for slaughter. Mr Jones was unable to confirm whether this would be a separate document to the new Passport. A working party from the BHS Horse & Pony Breeds Committee, including Mrs Renwick, Mrs Campbell and Mr Mansell, had been set up to look into this matter, to report back to the BHS who will deal direct with MAFF on welfare.

Hansepferd Exhibition, 24/28 April, Germany: The BHS has offered to distribute breed society leaflets from their own stand for a small charge.

10. Pony Pilgrimage

The starting point will be Dalemain on 9th May during the Stallion Show. Application forms were offered for interested participants. Two breed representatives per sector of the route (15 - 20 miles) were needed, these being free places, 50 people being needed to do a sector each, the dates now having been set. Followers are required to pay £10 to join in or obtain sponsorship. Third party insurance is compulsory, as are suitable hard hats and safe tack. Miss B Walker proposed a vote of thanks to Mrs Sheila Hardy of the Rights of Way Department of the BHS for all her work promoting bridleways and the native breeds.

11. Foal Disease Research & Fell Pony 2000 Up-Date

The Secretary outlined three developments since the Spring Newsletter had been printed. Namely, the Penrith team of vets headed by S Scholes had published its investigatory paper into the Syndrome in the Veterinary Record of 7th February, confirming the suspected genetic problem and calling for further investigations. The Horserace Betting Levy Board had accepted a submission by the Society for Fell Pony 2000 for grant aid, agreeing £2,300 which was most welcome. Finally, Fell Pony 2000's series of breeders'

meetings had started with Penrith, Kendal, Leahurst and Durham having taken place, Stoneleigh remaining.

Mr D Brunt, Secretary of FP2000, gave an updated report on their work. Current account balances weret £7000 with no debits having been made other than a cash float and registration fee for the Data Protection Register. The meetings to date had been self-financing with a target of £130 excess anticipated by the Stoneleigh date. Charity Commission registration was received on 28 January.

Using breeding records for this year, all breeders had been contacted personally to confirm details and obtain the name of their vets. All were subsequently invited to attend a meeting, this being 157 UK breeders representing 484 in-foal mares. 78 breeders replied, being a 50% return. Of those who replied, 50% have so far attended a meeting. The research focus has changed from the need for 12 affected foals to be taken to Leahurst to obtaining blood samples from as many foals as possible at birth, 24 hours old and 6 weeks of age. To date 28 breeders volunteered to supply samples from the progeny of their 118 mares, an excellent response. 8 volunteer vets, mostly in Cumbria, had also come forward to do work at reduced rates. Fell Pony 2000's aim is that every breeder is aware of the latest information relating to the Syndrome and the investigations. Recognising some could not attend, the Durham meeting had been recorded on video, loan copies of which would be made available to anyone wanting one. Mr Brunt praised the members who had volunteered to organise the meetings for FP2000 and the Cumbrian riding clubs which had held the first meeting presented by Dr Knottenbelt.

Major fundraising was due to start to raise the £25,000, mostly needed to fund an immunologist for 12 months at Leahurst. FP2000 is looking at contingencies including a possible semen bank of registered, blood typed stallions. Mr Brunt stressed the problems the Council will have to face with increasing demands from breeders asking which stallions are carriers and which matings are "safe". The questions are being asked already but until a carrier test is available they will continue. In the absence of a positive test, the responsibility must lie with a stallion owner to say if it is known the stallion has sired a diagnosed affected foal. He urged the Council to consider carefully the situation it will face as breeding information is collected, indentifying carrier ponies, and its responsibilities to all breeders. advances in research techniques, he indicated a resolution to the Syndrome is fast approaching and therefore the Council should not delay its deliberations. He recommended drawing on the experience of the traditional breeders to help preserve the typical Fell pony for the future in the light of the Syndrome. He appealed for divisions within the Society to be set aside to help achieve a successful outcome.

12. Pleasure Ride 1998

Miss R Brunskill kindly offered to organise this year's ride to be held on 27 September from Talkin Head in the Geltsdale Valley, near Brampton.

13. Members' Suggestions

Miss Longsdon asked for any members willing to sponsor a class for £25 at the Breed Show to put their names on the list.

14. Any Other Business

Mrs B Hodgson asked if Council candidates in future years could be requested to answer some members' questions before the voting took place as the candidates' information in the newsletter did not address important issues of relevance to the Society but more personal information. It was agreed that a few questions could be asked of each candidate in turn, in the interests of fairness, prior to voting. This would also identify candidates to voters who were unfamiliar with them, which was welcomed.

Mrs C Morland marked the loss of a hill herd, Mr Trotter's Tebay ponies on the Howgills, sold, many unregistered, within recent months at local sales. She referred to the economic hardship of farmers in today's market and the drop in prices due to widespread Syndrome publicity, some of it insensitive. Mrs Ball replied that by tackling the disease now, the Society was doing as much as it could to prevent a far worse consequence for the breed and breeders if the situation were ignored. She said that whilst the hill breeders' say they cannot sell youngstock, Mrs Laing cannot find enough ponies to satisfy sales enquiries.

Miss H Fell spoke of the Brockhole Lake District Festival in the Windermere area on August Bank Holiday which would be a good opportunity for positive publicity for the breed. Publicity materials are to be supplied.

Mr W Lloyd said the Fell breeders no longer feel well-represented within the Society due to the increase in owner-only members. The Secretary said recognised hill breeders were very well represented in Council proportionately. She added that it was the hill breeders themselves who had decided not to continue with the M&M scheme which paid premiums to hill mares during Mrs Bell's term in office. The HBLB list of approved areas of expenditure for grant money included hill schemes and if they wished to establish a new premium scheme to help keep ponies breeding on the fells, they should forward a proposal for the Council's consideration.

Results of the Council Election

Mr M Allen: 98 votes, Mrs M Murray: 93 votes, Miss B Walker: 88 votes, Mrs S C Morton: 78 votes, Mrs M Raines: 60 votes, Mr J Langcake: 54 votes. Mr Allen, Mrs Murray, Miss Walker and Mrs Morton were appointed to Council for 5 years, Mrs Raines was appointed for 1 year. There being no further business, the Chairman closed the meeting at 4 pm.

COUNCIL INFORMATION

RESULTS OF COUNCIL ELECTIONS 1998

At the Society's AGM on 28th March, 6 candidates stood for election to Council, of which 3 were retiring members seeking re-election. There were 5 vacancies. The retiring members were re-elected and were namely Mr M Allen, Mrs M C Murray and Miss B Walker. Mrs S C Morton was successful in being elected for a period of 5 years and Mrs M Raines was elected for a period of one year, filling the vacancy resulting from Mr J Gibson's resignation mid-term. Mrs M C M Laing was re-elected as President for a further year.

At the first Council meeting of the new Council held on 12 May 1998, in accordance with paragraph 9.2 of the Society's Memorandum & Articles of Assocation, Chairman and Vice-Chairman were selected. Mrs E A Ball announced she was stepping down from the Chair. Mr R B Charlton and Mr A W Morland were nominated; Mr Charlton took the majority vote and was duly appointed. Mr B M Allen was re-elected unopposed as Vice-Chairman.

NOMINATIONS FOR COUNCIL ELECTION 1999

Nominations must be received by the Secretary by 1st January 1999. They must be in writing and signed by two members. Members are not eligible for election to the Council unless they have been Full members of the Society for at least five consecutive years.

STALLION GRADING PROPOSAL

The proposal outlined in the Spring newsletter resulted in one letter (pro) and one telephone call (against) from members! In its August meeting the Council, which felt the timing was not right to introduce such a scheme, decided to shelve any plans to alter the At Home Premium Scheme for at least two years.

TEACH-IN DEMONSTRATION

Thank you to those members who contacted the Secretary for details of this event. It proved impossible to organise it for this autumn so it has been deferred until autumn 1999.

The facilities of the new Greenlands Equestrian Centre near Carlisle have been booked for 2nd October. There is a large indoor school, gallery seating for 150 people, restaurant, bar and ample car parking.

The day will focus on all aspects of showing under saddle and will be of interest to judges, trainees, riders and members in general. The event will require some "guinea pig" ponies and riders. Anyone interested in volunteering is invited to contact the Secretary.
